ALL APPLICATIONS MUST BE COMPLETED WITH THE REQUESTED DETAILS AND SIGNED. ANY APPLICATIONS NOT SIGNED OR COMPLETED IN THEIR ENTIRETY WILL BE RETURNED TO THE VENDOR. Booth spaces are available to those who meet the requirements stated in the application form and are accepted by the review committee.

**EARLY BIRD SPECIAL - \$50!!!, if you register by midnight, MARCH 3, 2026**, (postmarked by March 3)!!  
You will be notified of receipt of application and approval within 7 business days of receipt of your application.

**Booth fee after March 3, 2026 is \$75.** Final application postmark deadline is March 24, 2026; after that date there will be an additional \$25.00 late registration fee and applications will be accepted upon availability of spaces. Vendors will be notified of approval within 7 business days of receipt of your application. Application fees will be returned to those not accepted. Refunds will NOT be made to accepted vendors after March 3, 2026. There will be a \$75.00 charge for all returned checks.

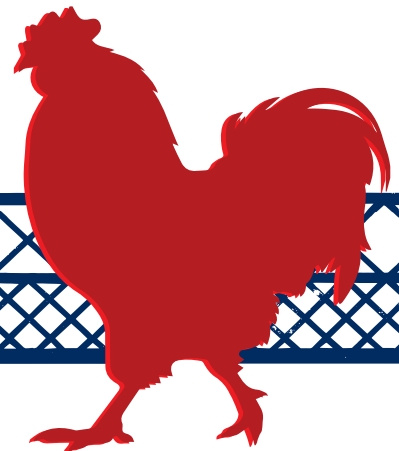

## VENDOR APPLICATION FORM – PLEASE RETAIN THIS PAGE FOR YOUR RECORDS

Print this page, then fill out and email or mail application form, mail check or pay through Venmo, and email photos or mail (**email preferred**).

Booth and Event Guidelines--Please read before filling out application.

1. Exhibit spaces are open to artists and crafters. Rooster Fair in Public Square is for **handmade, handcrafted items only**. Please make sure your application lists the products you will be selling. We ask that all vendors submit 3 photos of the items for the review committee, **emailed photos preferred**. The photos will be placed in your registration packet and will not be returned to you. Applications without photos will not be considered.

PLEASE NOTE: We reserve the right to deny you a booth the day of the event if your pieces do not reflect the photos submitted. Your application and booth fee will not be refunded.

Candidates for political office or representatives of political causes or parties, or religious missions DO NOT qualify as a vendor. We do not allow political or religious handouts. We do not allow political or religious solicitations on festival grounds.

2. Spaces will be assigned on receipt of registration. The Rooster Fair in Public Square review committee reserves the right to refuse space or close down an exhibit which fails to meet the guidelines and to assign booth spaces at its discretion.

Booths are roughly 12'X12'.

3. State law requires that a sales tax be collected on all sales. Each vendor is responsible for collecting necessary sales tax and reporting that tax.

4. Booth spaces are in the open air. No tables, chairs or tents will be furnished. You will be responsible for setting up and furnishing all equipment. Booths may start setting up by 6:30am Saturday. We ask that all booths be set up and ready for customers by 9am. If you need extra time, please let us know.

5. The hours for Rooster Fair in Public Square are from 9am to 4pm and you must remain open until 4p.m. The event takes place rain or shine, no refunds due to inclement weather. No refunds will be made once an application is accepted. This is a rain or shine event.

6. Cost of a 12'x12' booth with application postmark deadline March 3, 2026 is \$50. From March 4 - March 24, 2026 booth fee is \$75 and applications will be accepted upon availability of spaces. After March 24, there is an additional \$25 late registration fee. Vendors will be notified of approval within 7 business days of receipt of their application. Application fees will be returned to those not accepted. Refunds will NOT be made to accepted vendors after March 3, 2026. There will be a \$75.00 charge for all returned checks.

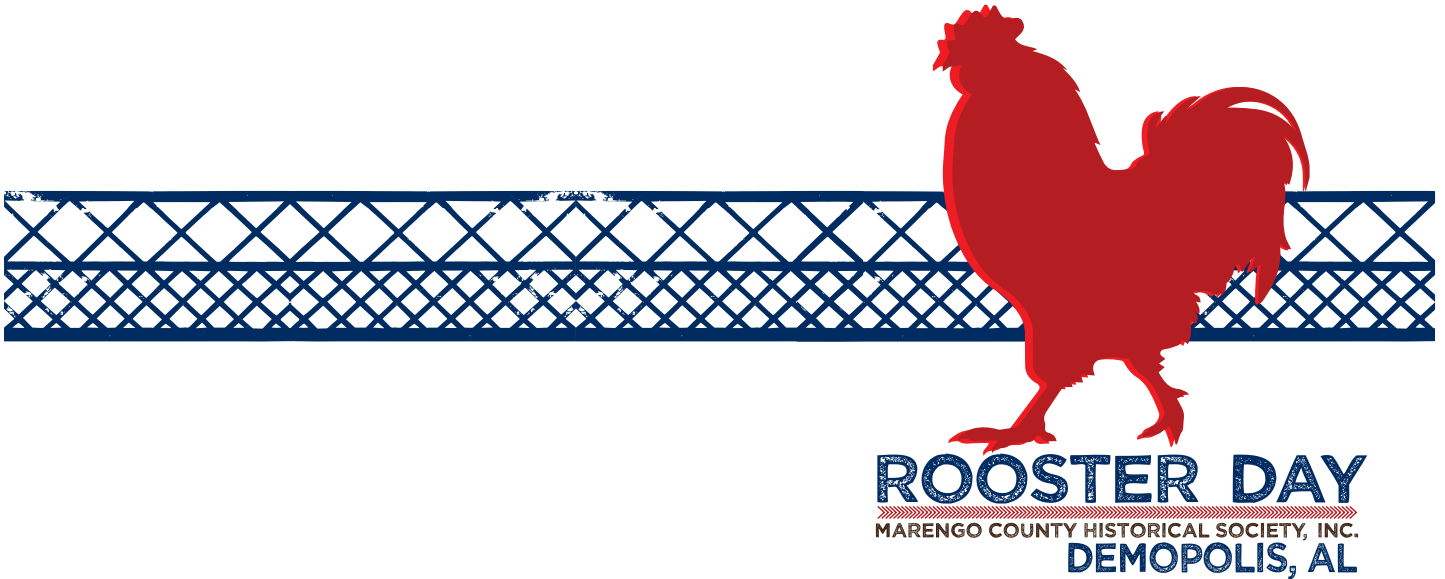
7. NO electricity is provided; personal generators may be used, unless the noise is too great. NO water is furnished.

8. NO PETS ALLOWED, with the exception of service animals.

9. Parking allowed in designated areas only. A list of the designated parking areas will be included in the confirmation letter. NO PARKING IN THE IMMEDIATE AREA OF THE SQUARE – THIS INCLUDES WALNUT AVENUE, CAPITOL STREET, WASHINGTON STREET, and MAIN AVENUE. ALL UNAUTHORIZED VEHICLES WILL BE TOWED AT OWNER'S EXPENSE.

10. Unloading and Loading zones will be restricted to Walnut Avenue, and the parking area behind Rooster Hall, off Capitol Street. No vehicles may remain in the parking area behind Rooster Hall.
